Methane to Markets Ministerial – Launch of the Global Methane Initiative Held October 1, 2010 - Mexico City

- Mexico's Environment Minister, Juan Elvira, and U.S. EPA's Assistant Administrator Gina McCarthy led Mexican & US delegations in launching an expanded effort to accelerate global methane reductions.
- They asked developed country Partners, and others in a position to do so, to make new financial commitments to this new Global Methane Initiative (GMI).
- The United States pledged at least \$50 million over five years to GMI.

Mexico City Ministerial (Cont'd)

The GMI builds on the existing structure of M2M and is supported by the revised Terms of Reference.

• Key New Elements of the Global Methane Initiative Include:

Expanded Scope

Abatement and avoidance from wastewater treatment, landfills, agriculture.

Methane Action Plans

All partner countries are encouraged to develop national methane action plans to coordinate methane reduction efforts at home and abroad.

Developed countries provide coordinated assistance to developing countries.

New Resource Commitments from Developed Country Partners, the International Community, and Others in a position to do so.

Ministerial (Cont'd)

- All existing Partners and activities under the Methane to Markets Partnership will become part of GMI.
- The Methane to Markets Partnership program materials will be modified over the coming months to reflect the enhancements and expansions of GMI – and a new brand will be developed.

Steering Committee Meeting: Overview

- Meeting was held concurrently with Ministerial event.
- Decision items included:
 - New Partners
 - TOR Adoption
 - Action Plans and Reporting
 - Wastewater Meeting/Recommendations
 - Partnership Expo

Steering Committee Meeting: Outcomes

- Approved Nicaragua and Turkey's requests to join the Partnership.
 - Nicaragua will participate in Agriculture and Landfill.
 - Turkey will participate in Coal Mines, Landfill, and Oil & Gas.
- Adopted Revised Terms of Reference (TOR) that now includes:
 - Action Plans and Reporting
 - Methane Abatement
 - Review of Leadership
 - New Sector (wastewater)
 - Global Methane Initiative

Steering Outcomes (Cont'd)

- Partnership Expo
 - Agreed to hold a third Methane to Markets Partnership Expo.
 - ASG will explore potential locations, Partners encouraged to notify ASG if they are interested in hosting.
 - Adopted the same basic framework as the previous Expo (e.g., concurrent sector-specific sessions, site visits, exhibition hall, project opportunities).

Action Plans/Reporting

- Agreed to move forward with development of country strategic action plans with initial drafts encouraged by end of 2011.
 - The ASG will develop list of questions to help partners to craft country strategic action plans. Questions will help to outline key elements of a plan.
- ASG will identify possible recommendations for streamlining reporting such as development of a template or general guidelines.
 - Partners are encouraged to report annually on activities/ accomplishments in support of their Action Plans.
 - Partners are encouraged to provide the ASG with specific comments on aspects of the current reporting system that could be improved to facilitate future reporting.
- The ASG will solicit specific feedback about the performance and operability of the on-line tracking system.

Wastewater Meeting

- Approval to move forward with a Wastewater Task Force meeting, to be held jointly with Agriculture and Landfill Subcommittee meetings.
- Partners were encouraged to identify additional participants for the Wastewater Task Force and/or meeting.

Action Plans/Reporting

 Subcommittees are encouraged to support and assist Partners in both the development and implementation of country strategic action plans.

Global Methane Initiative

Leadership

 Review current leadership and/or query delegates to determine if there might be other Partners interested in serving as chair(s).

Methane Abatement

 Determine the role of methane abatement within each sector, and update Subcommittee Action Plans accordingly.

Wastewater Sector

 Identify additional participants for the Wastewater Task Force
